- University of the District of Columbia: Started the spring semester last Monday and will have enrollment in the February meeting. Students are still figuring out their schedule. Building 32 and 42 will finish their solar panels installation this year, building 39 will finish their work early this year. Athletic Field has been pushed back to May because there was a water supply line issue so they are trying to work around that. For February, community task force will be on February 1. DC Archives will be the main guest on that. Founders Day is on February 15. Will reach out Commissioner Tandaric and would like to go to the February meeting. Been dialogue about hosting events for children.
- Van Ness Main Street: Nail Avenue was closed for almost 3 weeks due to new policies from DC Health. They are working to make sure no businesses shut down due to new policies. Spring plantings are starting. They will introduce the first Saturday there will be a small pop-up sale outside the VNMS building. They will welcome 4 more businesses to the corridor.

- Councilmember Robert White (7:40pm-8:00pm): Discussed his work from OANC to make changes to the agency. Talked about what issues they are experiencing in their neighborhoods. Included multiple types of housing and many meetings with constituents. Wanted to identify what are the biggest issues, what is causing them, and how they can be solved. One of the biggest problems is homelessness, which has increased greatly. Found that everyone already been approved a housing voucher years ago but there were major backlogs in the process. There are not enough social workers to do intake for them. Started a new Social Work program for free at UDC. As people were getting housed, there were numerous complaints about behavior and safety. Pushing to get superior courts for an expedited process for eviction notices for people causing safety problems, CM Henderson to collaborate with DBH, and his team to bring wraparound services closer to people in their homes.
- MPD (8:01pm 8:21pm): Used DC Crime Cards. Had 20 crimes compared to 24 crimes last year. One robbery. There was a decrease in property theft. There were 2 carjackings. Several retail thefts in the area.
- **DC Water** (8:22pm 8:42pm): Begin installation of sweeping cleanouts on Audubon Terrace. Will start next week of sewer bypass and CIPP Instillation at Broad Branch.
- ABCA License for Caldwell Family Vines, 4221 Connecticut Avenue, NW (8:43pm 8:53pm): The license will only be used for online storage and it is a Class A license. This will be voted on next month. There was a discussion regarding if this space will take up real estate that other businesses can use.
- BZA 21044 for 2918 Uptown Street, NW (8:54pm-9:04pm): The license is for a 2-story house and allow an extra few feet on a patio they are building. The owner of the house discussed with the ANC the BZA and will bring visuals next meeting when the ANC votes on it.
