ANC3F Grants Committee Report 2016

During the calendar year 2016, ANC3F approved five grants to community organizations for funds to conduct activities that benefit ANC3F residents. The table below summarizes the grants awarded in 2016. ANC3F allocated a total of \$11,825, \$5,500 of which was allocated to academic institutions, and \$6,325 was for neighborhood organizations and services.

I. Forest Hills Connection

A grant in the amount of \$3,000 was approved to fund the research and development of a multiyear funding plan with four main goals: (1) ramp up funding from the current budget of \$6,000 per annum to \$31,000 per annum; (2) expand and strengthen revenue streams; (3) plan for sustainability and succession; (4) chart the structural relationship between Forest Hills Connection and Van Ness Main Street.

II. IONA Senior Services

A grant in the amount of \$325 was approved to partially fund a pamphlet to be prepared and distributed by Iona Senior Services entitled "Where to find food in Ward 3." It is the Ward 3 version of a pamphlet that exists in all the other Wards in the District, and now exists for Ward 3.

III. Ben W. Murch Home and School Association (HAS)

A grant in the amount of \$3,000 was approved for the one-time purchase of sound equipment to be used in the temporary "swing space" and later in the modernized building. The school does not presently own sound equipment adequate for use in the swing space locations allocated for the auditorium, and the modernized building is in need of sound equipment for use in spaces other than the auditorium for instruction, smaller performances, meetings, assemblies and events. The sound equipment entails microphones and stands, a keyboard amplifier, powered loudspeakers, a 20-channel stereo mixer and a mixer bag. This list was assembled in consultation with the newly hired music teacher.

IV. Forest Hills Neighborhood Alliance/Rock Creek Conservancy

A grant in the amount of \$3,000 was approved for the summertime upkeep and maintenance of new plantings along Broad Branch Stream. The funds are for the stipend of a student summer intern, to be supervised by staff of Rock Creek Conservancy, to monitor, water, and maintain the 150 new plantings along the stream. The student is expected to need approximately 8 hours per day for the three months of the summer to complete the tasks, resulting in a nominal rate of \$6.25 per hour for the internship.

V. Wilson PTSO Track Boosters - Tiger Tenley Run

A grant in the amount of \$2,500 was approved to fund the T-shirts to be used during the second annual Tiger-Tenley community 5K/2.5K run and afterwards by the Wilson track team. The original grant application requested funds for a broader range of activities related to the Tiger Tenley run, but the grants committee recommended, and the ANC approved, funds directly related to the cost of run T-shirts.
