RESOLUTION CALLING FOR DDOT IMPROVEMENTS TO STREETSCAPE OF LINNEAN AVENUE, TILDEN PLACE, LINNEAN AVENUE AND LENORE LANE

WHEREAS ANC 3F is tasked with considering a wide range of policies and programs affecting its neighborhoods, including traffic, parking, and street improvements by § 1–309.10(a) of the Code of the District of Columbia, and

WHEREAS the residents of the affected neighborhoods have requested repaving and infrastructure improvements to their streetscape, as demonstrated by a petition signed by a majority of residents, and

WHEREAS the residents of the affected neighborhoods have demonstrated their concern for their streetscape by holding community meetings to discuss potential improvements and receive feedback from fellow residents and officials from the District Department of Transportation and the Department of Energy & Environment officials, and

WHEREAS the residents of the affected neighborhoods have taken action to improve their streetscape and combat issues like stormwater runoff by having 19 individual property owners enroll in the RiverSmart homes program earlier this year, and

WHEREAS the current condition of the affected neighborhoods poses hazards to residents, property, visitors and neighboring areas including Soapstone Valley Park, and

WHEREAS ANC 3F recently prioritized issues of streets and sidewalks in its neighborhoods by establishing a Streets & Sidewalks Committee,

THEREFORE, BE IT RESOLVED that ANC 3F requests that the District Department of Transportation (DDOT), in consultation with the Department of Energy and Environment (DOEE):

- Complete the repaying of the heavily damaged portion of Linnean Avenue NW from Tilden Street to Upton Street NW, which has already been added to DDOT's 2016 repair schedule, as soon as possible;
- Develop a comprehensive plan for Linnean Avenue NW from 4001 to 4010 and from 4020 to 2500 Upton Street NW including capital improvements to improve storm water management, prevent erosion along the roadway and reconstruct the roadbed and pavement;

- Recognize that, should this roadway improvement require installation of sidewalks, the neighborhood prefers that sidewalks be limited to one side of Linnean Avenue;
- Develop a comprehensive plan for Linnean Avenue NW from 4012 to 4018, Tilden Place NW, and Linnean Avenue NW from 4201 to 4209 and the 4200 block of Lenore Lane NW: street repaving and curb repair that does not require installation of sidewalks or, alternatively, that qualifies for a waiver from DDOT requirements regarding sidewalk installation within road reconstruction sites;
- Study and, where appropriate, recommend additional infrastructure improvements including Low Impact Development (LID) techniques to capture stormwater as close to the source as possible;
- Commit to a schedule for the completion of design, required budget and construction and report those dates to the community and ANC 3F;
- Meet with members of the community and ANC 3F to explain designs and schedules, solicit comments, and finalize the design to incorporate neighborhood feedback.



BE IT FURTHER RESOLVED that further deliberation on this issue will be referred to ANC 3F's Streets & Sidewalks Committee,

BE IT FURTHER RESOLVED that Commissioners Nugent and Jakopchek are authorized to speak on behalf of ANC 3F regarding this matter.
