#### 5. Other Updates:

- Burger King
  - Carol Rosenblatt: Noted she was friendly with the Burger King workers and its recent sudden closure. Requested that the ANC to express their displeasure about the sudden closure, firing, and lack of notice to the community about the closure.
  - Various commissioners expressed their concern with the issue and their individual desire to look to see what can be done as an ANC. Commissioners requested anyone with information to please email the Commission.

#### 6. Regular Agenda - Information Items

# 1. ANC 3F Public Safety Update from Second District, Metropolitan Police Department (MPD)

- Lieutenant Williams was the previous community correspondent
- Captain Ronald Bridges has replaced Williams and will be giving us safety updates for our area for the time-being.
- Crime Cards updates:
  - No homicides, no sexual abuse cases, 2 assaults with deadly weapons, no robberies, one verbal, uptick in theft from autos
    - 4607 Connecticut Ave, December 23<sup>rd</sup>, 2022 assault with a deadly weapon, subject arrested.
    - Accident involving two vehicles, subject brandished a weapon and got out of the car and took the others vehicle
    - Recommends not to leave personal items in vehicles
    - 4007 Connecticut Ave, subject gained entry to apartment building and accessed mail-room and made off with items
      - Messed with security cameras and gained entry
  - 3500-4500 Connecticut block, lots of business dealing with theft issues
- MPD conducted a community walk with around 15-20 people in ANC 3C that led into 3F
  - Commissioners expressed concern that the community walk was planned last-minute, that ANC 3F was not informed of the concerns expressed in the Van Ness area and whether there will be more walks and whether they would be consistently recurring.
  - MPD apologized for the last-minute planning, informed the Commission that it will be tasking its community outreach workers to conduct more walks and walks dedicated to ANC 3F.
  - Some of the concerns expressed in the Van Ness Area at the community walk:
    - Theft, quality of life concerns.
- A constituent asked about updates related to a specific criminal case
  - MPD said they would follow up with the constituent.
- A constituent asked about what plans and processes are in place for MPD to implement and enact a modified Idaho stop / right turn law
  - MPD said they would follow up by the next ANC meeting or sooner
- Claudette David reiterated her desire for the Commission to be copied on communications between MPD and constituents regarding these issues

- Claudette David informed MPD that the Commission will be conducting quarterly meetings with building managers in the area and would like MPD to join these meetings
  - MPD informed the Commission that Captain Bridges and other officers went to 8-9 buildings in the area to meet with their respective management regarding security.
  - Claudette and Teri Huet requested information whether recent crimes that happened in the community were from community members or from outside of the area.
    - MPD noted that they did not check as most of the thefts were crime of opportunity.
- The Commission and MPD reminded the community to always report crime they witness
- A constituent residing in 4500 Connecticut Avenue alleged under-reporting of crimes in their building due to threatening notes placed on unit doors, and aggressive panhandling from a building resident.
